Current Funded Partner, Venture Grants: Grants are available for new program ventures up to \$5,000.00. This is to help you see if a particular program will work and meet viable needs in our community.

Include: Letter to Board of Directors describing program description, need and how the funds will be utilized, timeline and number of people to be served.

Current Funded Partner, Emergency Funds: Grants are available for currently funded partners to meet unforeseen and non-continuing issues.

From \$200.00 up to \$7,500.00

Include: Letter to Executive Director stating need, urgency and how the issue will be resolved with these funds.

New Partner Programs: Grants are available for organizations not currently funded through United Way partnership. You must be meeting a community need in one of our four key areas: Health/Mental Health, Basic Needs, Workforce Development or Youth Development.

Include: Application, Most recent Form 990, IRS Determination Letter, and List of Current Board Members.
